

## INSTANT REPLAY™ OVERVIEW

The Instant Replay™ program offers players a second chance to win \$1,000,000 with eligible non-winning Michigan Lottery instant game tickets. To participate in the program, players are required to enter their non-winning tickets online at the Michigan Lottery Player's Club™ website. For every \$10 in qualifying tickets submitted through the Code Entry page on the Michigan Lottery Player's Club™ website a player will automatically earn one (1) entry into the drawing pool. Players are also earning Reward Points for every valid ticket submission which can be utilized separately for redemptions in the Michigan Lottery Player's Club™ prize catalog.

For each promotional period, three (3) finalist drawings and one (1) \$1,000,000 grand prize drawing will be conducted. In each finalist drawing one (1) entry will be selected to receive access into the grand prize drawing in which one (1) winner will be selected to receive the \$1,000,000 grand prize. Entries will be destroyed after each finalist drawing. A player may be selected as a finalist one time only for each promotional period. Players must be a member of the Michigan Lottery Player's Club™ in order to participate.

## IMPORTANT PRIZE CLAIM INSTRUCTIONS

To be validated as a \$1,000,000 Grand Prize finalist in an Instant Replay™ drawing, entrants are required to provide the Michigan Lottery with the actual tickets that made up their entry selected in the finalist drawing. If a finalist is unable to produce the tickets that made up their selected entry by the claim deadline, the finalist is disqualified and the designation will be awarded to an alternate, according to the Lottery's established drawing procedures.

Finalists will be invited to appear on the September 2010 episode of the Lottery's TV game show, Make Me Rich!, to participate in the Grand Prize drawing for \$1,000,000. The game show broadcast schedule can be found on the Lottery website.

### **ELIGIBLE TICKETS**

Only Michigan Lottery instant game tickets that satisfy ALL of the following criteria are eligible for entry into the Instant Replay program:

- The ticket must be a non-winning cash prize ticket.
- The ticket must not be from a game that awards the top cash prize(s) in a drawing. (For example, most \$20 instant games)
- The ticket must not have expired, per the expiration date printed on the back of each ticket, at the time of entry into the drawing pool.

### **HOW TO ENTER**

- Entries will be received online only at the Michigan Lottery Player's Club™. No mail entries allowed.
- A participant must register as a Michigan Lottery Player's Club™ member with their legal name, street address, city, state, ZIP code, valid e-mail address and valid contact telephone number.
- Each entry into the drawing pool must consist of \$10 worth of eligible tickets. Any of the following \$10 combinations will constitute one (1) entry into the drawing pool:
  - One \$10 ticket
  - Two \$5 tickets
  - One \$5 ticket, two \$2 tickets and one \$1 ticket
  - One \$5 ticket, one \$2 ticket and three \$1 tickets
  - One \$5 ticket and five \$1 tickets
  - Five \$2 tickets
  - Four \$2 tickets and two \$1 tickets
  - Three \$2 tickets and four \$1 tickets
  - Two \$2 tickets and six \$1 tickets
  - One \$2 ticket and eight \$1 tickets
  - Ten \$1 tickets
- **One ticket from \$20 game #252-Casino Game Book when submitted by May 24, 2010 will constitute two (2) entries into the drawing pool**
- For each ticket comprising an entry, participants must submit the 8-digit ticket number found on the front of the ticket which is concealed beneath the scratch play area.
- Most tickets earn 1 Reward Point per \$1 in ticket value. There is no cash value for Reward Points.

- Eligible tickets may be submitted into the Instant Replay™ program one time only.
- Entries will be eligible only for the entry period in which they were submitted.
- Tickets submitted by **mail** as entries into Michigan Lottery Second Chance Bonus Zone® games will not be eligible for entry into Instant Replay.
- Michigan Lottery Player's Club™ members may submit up to 20 qualifying tickets per day, however, the Michigan Lottery reserves the right to limit the number of entries any one individual may enter during a given time period.
- A Michigan Lottery Player's Club member will be considered ineligible and their entries and associated Rewards Points voided if the Lottery determines that the member provided false ticket or membership information.
- Michigan Lottery Player's Club members must retain, and provide to the Lottery, each eligible ticket used for a valid entry as proof of purchase in the event their entry is selected as a finalist.
- The entry deadline is Midnight, Eastern Time on the night of the entry deadline.
- All entrants must be at least 18 years old.

## **DRAWINGS**

- Entry deadline and drawing dates are subject to change. Changes will be announced by the Lottery at least 30 days prior to each drawing.
- In each finalist drawing, one (1) finalist will be randomly selected from the pool of valid entries. Once a finalist is confirmed by the Lottery, he or she will be placed in the drawing pool for the Grand Prize drawing.
- The Grand Prize drawing will be conducted from the pool of the three (3) selected finalists.
- In the Grand Prize drawing, one (1) winner will be randomly selected to receive a \$1,000,000 prize.
- The Grand Prize drawing will be conducted on the Lottery's televised game show, "Make Me Rich!"
- The exact dates for the show's taping and broadcast will be announced by the Lottery at least 30 days prior.
- A Player City member may be selected as a finalist only one (1) time in each promotional period.
- The date and location of the \$1,000,000 Grand Prize drawing will be announced by the Lottery at least 30 days prior.
- For each finalist drawing, alternate entries will be drawn, and if necessary, will be substituted for disqualified entries in accordance with the official game rules and drawing procedures.
- All entries in a drawing will have an equal chance of being selected.
- The odds of being selected as a finalist depends on the number of entries received for the drawing.
- Participants need not be present to win. The Michigan Lottery will contact finalists by telephone within twenty four (24) hours of the drawing. If all attempts to locate a finalist fail by within ten business days, excluding State of Michigan holidays, an alternate will be selected in accordance with the Lottery's established drawing procedures.

## **PRIZES**

- The \$1,000,000 Grand Prize winner will receive their prize in annual payments over a 20-year period unless, within 60 days from the date they claim their prize, they request the Cash Option method of payment.
- The Michigan Lottery will withhold and deposit the required state and federal withholding taxes on behalf of the \$1,000,000 prize winner. Any additional federal, state and/or local taxes or other fees or personal expenses are the responsibility of the winner. The Lottery is not responsible for additional taxes that may be due when the winner files tax returns.
- In accordance with Public Act 11 of 1994, if the winner of a lottery prize is identified by the Michigan Lottery as owing an outstanding debt to a state agency, this outstanding debt shall be deducted from the cash value of the prize and the balance, if any, paid the winner, less applicable taxes. If the winner is identified as owing a debt to a state agency that is greater than the cash value of a prize, the entire cash value amount, less applicable taxes, shall be applied towards that debt.

### **PRIZE CLAIM INSTRUCTIONS**

- Finalists will be contacted by the Michigan Lottery with prize claim instructions. The list of Grand Prize Finalists will be posted on Player City after each finalist has been contacted by the Michigan Lottery and their entry validated.
- To be validated as a finalist, entrants are required to provide the Michigan Lottery with the eligible tickets that made up their winning entry. If a finalist is unable to produce the tickets that made up their winning entry by the claim deadline, the finalist is disqualified and the designation will be awarded to an alternate, according to the Lottery's established drawing procedures.

### **PROMOTION CHANGES AND TERMINATION**

The Michigan Lottery reserves the right to change the Instant Replay™ program in any way and at any time, and to terminate the program subject to appropriate public notification.
